3. **Composition, Information or Ingredients**

4. **First Aid Measures**

- Ingestion:** Do NOT induce vomiting. Give water to victim to drink. Seek medical attention.

- Extinguishing media:** Carbon dioxide, dry chemical powder, alcohol or polymer foam.

6. **Accidental Release Measures**
